Dear Adoptive/Guardian Parent(s):

The Oregon State Parks and Recreation Department provides free day use and over night use of state parks to parents/guardians who became the adoptive parent or guardian of a child who was in the Oregon foster care system at the time of the adoption or guardianship.

If you are an adoptive parent or guardian who wishes to use this benefit, you must complete the form, "Adoptive or Guardian Family Fee Waiver Program Verification Letter" and send it to Oregon State Parks and Recreation. This form identifies you as the adoptive parent or guardian of a former Oregon foster child. The form is included for your convenience.

You will then receive a plastic identification card which will be valid up to the time your **youngest adopted or guardianship former foster child turns 18**. The identification card provides your family the documentation needed for the fee waiver. In order to assist Oregon State Parks with the verification process, please locate your adoption assistance or guardianship assistance coordinator from the following list and place his or her name and phone number on the bottom of the form.
